Pineville Fall Fest will celebrate its 24th year at a **new location**. The event will be held at Jack D. Hughes Park/513 Main Street Pineville, NC, this fall. This family oriented outdoor festival will take place on Oct. 14th & 15th, welcoming over 10,000 festivalgoers. This festival is focused on promoting arts, crafts, entertainment, musicians and family fun. We hope you will consider becoming one of our concessionaires at our festival. Our aim is to offer a vast menu of food at a fair value. During the selection process, we will look for concessionaires who provide one or more of the following: the traditional festival fare, a health conscious menu, and unique specialty items. Concessionaire spaces range from \$150 to \$375 per location. **Concessionaires are required to participate on Friday, October 14th 6:00P-10:00P and Saturday, October 15th 10:00A-10:00P.**

Concessionaire Application Process: Once you've completed the application portion, return it with **a photo** of your vending unit, **food menu items and pricing**, and a **certificate of insurance**. Upon acceptance we will also require you to fill out a Temporary Food Event Application from the Mecklenburg County Health Department. You must return these forms to us by **September 16th, 2022** in order for us to send in the info to Health Dept. **NO EXCEPTIONS.**

APPLICATION DEADLINE Friday, September 16th (or until we are full)

Festival Set-Up: Friday, October 14th (10:00A-3:00P, must be set up by 3:00 for Health Dept. Inspections) (**security overnight**)
Saturday, October 15th (10:00A-10:00P)

PINEVILLE FALL FEST PROVIDES THE FOLLOWING

- Tent/Food Truck location assignment (all locations are assigned at the Festival's discretion).
- All concessionaire locations are accessible by vehicles for set-up and break-down.
- Security will be provided Friday night October 14th and during the festival.
- One concessionaire parking pass. **No exceptions.** Passes will be distributed at check - in on Friday, October 14th.

PINEVILLE FALL FEST DOES NOT PROVIDE THE FOLLOWING

- Tents or Display equipment for setup of exhibit
- Tables or chairs
- Electricity/Electrical Equipment (including drop cords, light bulbs, fixtures, generators, etc.)
- No water source provided

RULES AND REGULATIONS

- Awarded spaces are nontransferable. No one will be allowed to exhibit without first having juried into the Festival and having paid the concessionaires fee to the Festival. Shared spaces are not permitted. Displays must fit into designated spaces without infringing upon neighboring spaces.
- Menu prices must be posted. You may sell only the food and drink listed on your application and approved by the committee. We will limit the number of vendors selling major items. This is to protect you and other vendors by eliminating duplication of food and drinks.
- Each concessionaire must realize this is an outdoor show; there is some uneven ground and weather can be uncooperative. Please make sure you secure your tent. This is a rain or shine event. There is no rain date. **NO REFUNDS** will be made in the event of rain.
- This festival is family oriented. All exhibits must be in keeping with this atmosphere. The festival staff reserves the right to prohibit any merchandise which is questionable in nature.
- Concessionaires are responsible for maintaining and leaving their assigned areas clean and free of trash, and in otherwise good condition.
- Each concessionaire is responsible for the collection of North Carolina and County of Mecklenburg sales tax.
- The Pineville Fall Fest will not be responsible in any way for any damages to the work of any person or persons participating in the Festival.
- All vehicles must be removed from the exhibit area by 3:00P on Friday, October 14th.
